**REGISTRATION NOTE**

In accordance with established OMSA policy, all members attending the convention are expected to share the expense of the convention by paying the full registration fee and by patronizing the convention hotel, which helps offset bourse and exhibit room rental costs. The registration fee includes a non-recoverable amount for the breakfast and banquet. The convention is open to the public on Saturday from 9:00 a.m. to 5:00 p.m. *OMSA members who do not register for the convention may only participate during the public hours on Saturday.* Non-members who wish to participate in any aspect of the convention other than the public bourse on Saturday must first complete a membership application and remit annual dues, in addition to paying the full convention late registration fee.
